



## Waiver of Liability and Release

I, in consideration for my voluntary participation with Reaching Goals Soccer Academy, acknowledge that my consent via registration attests to my understanding and agreement to the following:

My athlete's status will be kept in good standing. I agree to pay for any and all damages to any property or equipment caused by my athlete willfully, negligently or otherwise.

Soccer is a physical, contact sport that involves the risk of injury. I assume all risks and hazards associated with my athlete's participation in the sport. My athlete is in proper physical condition to participate in soccer training and has no illness, disease or existing injury or physical defect that would be aggravated by participation. I am responsible for informing the coach of any changes regarding physical condition. I further acknowledge that this risk may involve loss or damage to my athlete, including the risk of death, or other unforeseen consequences, including those which may be due to the unavailability of immediate emergency medical care. I have a current medical release form in force.

COVID-19: The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. Reaching Goals Soccer Academy has put in place preventative measures to reduce the spread of COVID-19. However, RGSA cannot guarantee that I or anyone else will not become infected with COVID-19, including my spouse, guests, unborn child, or relatives. Participation in an RSGA program, related event, or activity, could increase the risk of contracting COVID-19. By signing this agreement, I ACKNOWLEDGE the contagious nature of COVID-19 and VOLUNTARILY ASSUME THE RISK that I may be exposed to or infected by COVID-19 by participating in an RGSA program, related event, or activity, and that such exposure or infection may result in personal injury, illness, permanent disability, and death to myself, my spouse, guests, unborn child, or relatives. I understand that the risk of becoming exposed to or infected by COVID-19 at an RGSA program, related event, or activity may result from the actions, omissions, or negligence of myself or others, including, but not limited to, RGSA employees, volunteers, and program participants. I UNDERSTAND AND VOLUNTARILY ACCEPT AND ASSUME ALL the foregoing risks related to COVID-19 and accept sole responsibility for any injury or illness that may occur. Further, I UNDERSTAND AND AGREE that this release includes any claims based on the actions, omissions, or negligence of RGSA, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any RGSA program, related event, or activity.

Reaching Goals Soccer Academy encourages participants to have a current, active, personal injury insurance policy in force, which covers participation in this program. Under any condition, I am responsible for any and all medical expenses arising from my athlete's participation in this program. I have the right and responsibility to inspect equipment and facilities prior to participation and, if I believe that anything may be unsafe, I will advise the coach of the condition and may refuse my athlete's participation. Participation assumes consent.

I authorize my athlete's photograph, picture or likeness, and voice to appear in any documentary, promotion (including advertising), social media, television, video, or radio coverage of the program, without compensation.

I release, waive liability, and agree not to sue Reaching Goals Soccer Academy and/or any coaches, volunteers, participants or any other personnel, from any and all liability incurred in the conduct of, and my athlete's participation in, this soccer program.

I have completely read this document and fully understand its contents. As the parent and natural guardian or legal guardian of the athlete, I agree to the Waiver of Liability and Release for, and on behalf of, the athletes named above. I bind myself, the minor, and all other assigns to the terms of the Waiver of Liability and Release. I represent and certify that I have the legal capacity and the authority to act for, and on behalf of, the minor in the execution of this Waiver of Liability and Release.
